THE MAGIC OF PLAY BRINGS JOY AND LEARNING TO KIDS WITH DISABILITIES

Watch out! That's Adam behind the wheel of the big red plastic car coming toward you. He's three, and driving down the hall is just too much fun to worry about who's in the way.

Stroll the halls of Lekotek of Georgia and you may hear the delighted giggles of six-year-old Justin, feeding flies to a frog on the computer.

Take a peek in our cheerful playroom. That's two year old Zoe and her parents sitting on the floor, happily surrounded by toys. That beaming smile on Zoe's face comes from her latest accomplishment. She successfully placed a set of cars onto the eye-level track and visually tracked them as they rolled down each level to the bottom.

WELCOME TO LEKOTEK

Since 1983 Lekotek has been opening doors for children with Down syndrome, spina bifida, cerebral palsy, muscular dystrophy, autism, developmental delays, genetic disorders, hearing and visual disabilities, and chronic and terminal illnesses. Lekotek leaders, trained in special education, use select toys, computers and adapted devices designed to develop fine motor skills, language and choice making abilities. The Lekotek inventory is comprised of over 2200 items and all are available to families to take out on loan. Children look forward to the ever changing array of experiences and successes as each new toy is introduced. Parents, too, enjoy having access to a diverse selection of toys that facilitate the development of skills and greater independence at home and school.

While meeting the needs of children with special needs, Lekotek play sessions provide family members with a time to share their feelings. Sessions can be safe havens for just "letting it out." Or, they can simply be an opportunity to celebrate the joys and accomplishments of a child with special needs. Lekotek helps parents and siblings focus on the child's abilities rather than disabilities. Family members are encouraged to participate in our dad's group, mom's share group, sibling program and social activities that include picnics and play dates. While typical therapies are designed to meet the needs of the child, Lekotek strives to meet the needs of the entire family while developing the child's cognitive, language and motor skills.

Lekotek is a nonprofit organization. Our staff and board of directors conduct an annual silent auction. The silent auction will be held November 6th, 7th and 8th, 2017. Our goal is to raise funds to provide services to children currently waiting for services. Please help make a difference for children who do not have time to wait.
